Passport Hong Kong (SAR China)

Warning:

Passports and other travel documents accepted for entry are considered valid until the day before the expiration date.

Type: Critical

Visa Hong Kong (SAR China)

Visa required.

Visa Exemptions:

Passengers with a Hong Kong (SAR China) passport.

Nationals of China (People's Rep.) with a Travel Permit to and from Hong Kong and Macao with an exit endorsement issued by a Public Security Bureau Office in Mainland China stating purpose of entry.

Nationals of China (People's Rep.) with a China (People's Rep.) Travel Permit to Hong Kong and Macao (One-way Permit), with an endorsement to travel to Hong Kong (SAR China).

Passengers with a China (People's Rep.) Travel Document (Lu Xing Zheng) with an entry permit for Hong Kong (SAR China) .

Passengers with a passport issued by China (People's Rep.) in transit (including overland) to/from a third country for a maximum stay of 7 days.

Nationals of China (People's Rep.) with a China (People's Rep.) Travel Permit to and from Taiwan (Lu Bao Zheng) with an exit endorsement to Taiwan, if in transit to/from Chinese Taipei for a maximum stay of 7 days.

Passengers with a Macao (SAR China) passport for a maximum stay of 7 days.

Warning:

Visitors not holding return/onward tickets could be refused entry.

Type: Ok

Health Hong Kong (SAR China)

Vaccinations not required.

Type: Critical

Visa Philippines

Visa required.

Visa Exemptions:

Passengers with a Hong Kong (SAR China) passport for a maximum stay of 14 days.

Passengers with a Macao (SAR China) passport for a maximum stay of 14 days.

Nationals of China (People's Rep.) with a normal passport or a "Passport for Public Affairs" and a valid visa issued by Australia, Canada, Japan, USA or a Schengen Member State . This does not apply to passengers with a Crew Visa or Transit Visa. They must travel as tourists for a maximum stay of 7 days.

TWOV (Transit Without Visa):

Passengers with a confirmed onward ticket for a flight to a third country within 24 hours. They must stay in the international transit area of the airport and have documents required for the next destination.- TWOV does not apply when transiting between terminals. A visa and an airline escort are required.

Health Philippines

Vaccination against yellow fever required if arriving within 6 days after leaving or transiting countries with risk of yellow fever transmission .

Exempt from Yellow Fever vaccination:

Passengers transiting the Philippines if not leaving the transit area.

Passengers transiting countries with risk of yellow fever transmission if not leaving the transit areas.
